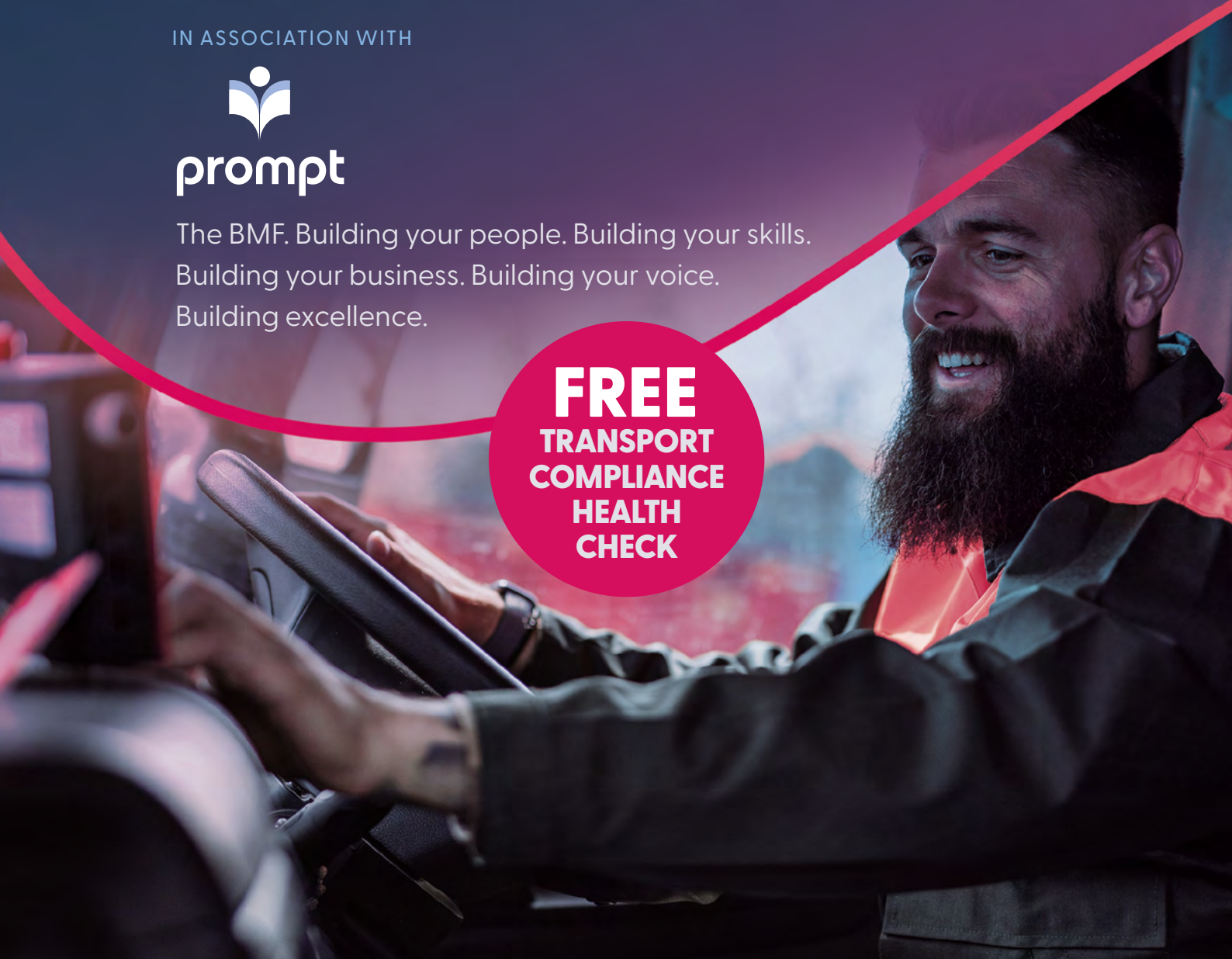

DVSA has changed its focus on how the licences of road transport safety and goods vehicle operators are managed. Targeted enforcement enables effective use of resource. This is made possible by increased use of data including ANPR and enabling exemplar operators to join the DVSA Earned Recognition Scheme.

In addition, the work of the Remote Enforcement office is freeing up DVSA staff for roadside enforcement and site visits.
